

US Equestrian Federation Entry Agreement

By entering a US Equestrian recognized Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Vaulteur, Longeur or Handler and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Constitution and Rules of the US Equestrian Federation and the local rules of the competition. I agree to be bound by the Constitution and Rules of the US Equestrian and of this competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the US Equestrian, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the US Equestrian and/or this competition may use or assign photographs, videos, audios, cablecasts, or other likenesses of me and my horse taken during this course of competition for the promotion, coverage or benefit of the competition, sport or the US Equestrian. Those likenesses shall not be used to advertise a product and they may not be used in such a way to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of US Equestrian rules are governed by the laws of the State of New York, any action instituted against the USA Equestrian must be filed in New York State. See Art. 1502.5.

US Equestrian Federation Release, Assumption of Risk, Waiver and Indemnification

THIS DOCUMENT WAIVES IMPORTANT LEGAL RIGHTS. READ IT CAREFULLY BEFORE SIGNING.

I AGREE in consideration for my participation in this Competition to the following:

- I AGREE THAT I CHOOSE TO PARTICIPATE VOLUNTARILY IN THIS COMPETITION WITH MY HORSE, AS A RIDER, DRIVER, HANDLER, LESSEE, VAULTER, LONGEUR, OWNER, AGENT, COACH, TRAINER OR AS PARENT OR GUARDIAN OF A JUNIOR EXHIBITOR. I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND THE COMPETITION INVOLVE INHERENT DANGEROUS RISKS OF ACCIDENT, LOSS, AND SERIOUS BODILY INJURY INCLUDING BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, SUFFERING, OR DEATH ("HARM").
- I AGREE TO RELEASE THE US EQUESTRIAN, THE PCHA AND THE COMPETITION FROM ALL CLAIMS FOR MONEY DAMAGES OR OTHERWISE FOR ANY HARM TO ME OR MY HORSE AND FOR ANY HARM CAUSED BY ME OR MY HORSE TO OTHERS, EVEN IF THE HARM RESULTED, DIRECTLY OR INDIRECTLY, FROM THE NEGLIGENCE OF THE US EQUESTRIAN, THE PCHA OR THIS COMPETITION.
- I AGREE TO EXPRESSLY ASSUME ALL RISKS OF HARM TO ME OR MY HORSE INCLUDING HARM RESULTING FROM THE NEGLIGENCE OF THE USA EQUESTRIAN AND THE COMPETITION.
- I AGREE TO INDEMNIFY (THAT IS, TO PAY ANY LOSSES, DAMAGES, OR COSTS INCURRED BY) THE US EQUESTRIAN, THE PCHA AND THIS COMPETITION AND TO HOLD THEM HARMLESS WITH RESPECT TO CLAIMS FOR HARM TO ME OR MY HORSE, AND FOR CLAIMS MADE BY OTHERS FOR ANY HARM CAUSED BY ME OR MY HORSE AT THE COMPETITION.
- I HAVE READ THE US EQUESTRIAN RULES ABOUT PROTECTIVE EQUIPMENT, INCLUDING ARTICLES 318 AND 1712 AND I UNDERSTAND THAT I AM ENTITLED TO WEAR PROTECTIVE EQUIPMENT WITHOUT PENALTY, AND I ACKNOWLEDGE THAT THE US EQUESTRIAN STRONGLY ENCOURAGES ME THAT I DO SO.
- IF I AM A PARENT OR GUARDIAN OF A JUNIOR EXHIBITOR, I CONSENT TO THE CHILD'S PARTICIPATION AND AGREE TO ALL OF THE ABOVE PROVISIONS AND AGREE TO ASSUME ALL OF THE OBLIGATIONS OF THIS RELEASE ON THE CHILD'S BEHALF.
- I AGREE THAT THE US EQUESTRIAN, THE PCHA AND THIS "COMPETITION" AS USED ABOVE INCLUDES ALL OF THEIR OFFICIALS, OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, PERSONNEL, VOLUNTEERS AND AFFILIATED ORGANIZATIONS.
