## EARL WARREN SHOWGROUNDS RV RULES AND REGULATIONS

**PURSUANT TO THE CALIFORNIA RECREATIONAL VEHICLE OCCUPANCY LAW, THE RECREATIONAL VEHICLE OF ANY RV OCCUPANT MAY BE REMOVED FROM THE PREMISES WITHOUT A JUDICIAL HEARING UPON 72 HOUR WRITTEN NOTICE TO OCCUPANT FOR: 1) FAILURE TO PAY FOR SUCH OCCUPANCY, OR 2) FAILURE TO COMPLY WITH THE RULES AND REGULATIONS OF THE PARK.**

- **ALL RESERVATIONS MUST BE MADE AND PAID FOR IN AT LEAST ONE WEEK IN ADVANCE.** PAYMENT WILL BE IN FORM OF CREDIT CARD. NO PERSONAL CHECKS ACCPETED.A CREDIT CARD AUTHORIZAZTION FORM MUST BE INCLUDED FOR ALL RESERVATIONS.
- RV MANAGER WILL COLLECT FEES AND ISSUE PERMITS. RV MANAGER WILL DESIGNATE PARKING SPACES.
- MAXIMUM STAY OF 10 CONSECUTIVE DAYS. SPACES ARE LIMITED, **NO RESERVATIONS WILL BE HELD WITHOUT PRIOR PAYMENT**
- SPACES ARE BACK-IN ONLY. VEHICLES MUST DISPLAY PROPER PERMITS AT ALL TIMES
- ALL RVS/CAMPERS/VEHICLES MUST BE CONTAINED WITHIN THE ASSIGNED SITE. ONLY ONE RV OR TRAILER PER SITE ANY RV/VEHICLE/CAMPER TAKING MORE THAN ONE SITE WILL BE CHARGED FOR THE ADDITIONAL SITE USED. **NO PARKING IN EMPTY/UNOCCUPIED SITES.**
- ALL VEHICLES MUST BE IN COMPLIANCE WITH CALIFORNIA DEPARTMENT OF MOTOR VEHICLE CODE.
- ALCOHOL, DRUGS, WEAPONS, FIGHTING, LEWD CONDUCT, RECKLESS DRIVING, SPEEDING, SKATE BOARDING, LOUD NOISE OR ANY CONDUCT DEEMED TO BE A NUISANCE OR A VIOLATION OF LAW ARE NOT PERMITTED AND VIOLATORS WILL BE EVICTED FROM THE FACILITY.
- NON-CONTAINED FIRES FOR COOKING AND /OR HEATING ARE NOT PERMITTED.
- ANY TYPE OF FENCING, BARRIERS, PALLETS ETC. ARE NOT PERMITTED
- THERE IS NO STORAGE OF ANY TYPE ALLOWED AROUND THE RV, CAMPER AND/OR VEHICLE
- ALL RV SITES MUST BE KEPT CLEAN FOR THE ENJOYMENT OF ALL THE OCCUPANTS.
- NO WASHING OF ANY VEHICLE OR REPAIRS OF ANY KIND ARE PERMITTED.
- **QUIET TIME IS FROM 10:00 P.M. TO 7:00 A.M, NO TENTS ALLOWED ON RV SITES.**
- SELLING, ADVERTISING OR DISTRIBUTION OF ANY PRODUCT (INCLUDING ALCOHOL) IS PROHIBITED
- "THE DUMPING OF SEWAGE ONTO THE GROUND IS IN VIOLATION OF THE CALIFORNIA HEALTH AND SAFETY CODE, SECTION 5411. ALL SEWAGE FROM RV'S AND CAMPERS MUST BE CONFINED AND THEN PROPERLY DISPOSED OF TO THE PUBLIC SEWAGE SYSTEM VIA DUMPING STATIONS." **UNITS FOUND TO BE IN VIOLATION ARE LIABLE AND WILL BE PROSECUTED.**
- DOGS MUST BE LICENSED AND KEPT ON A LEASH (MAX. 6 FT.) AT ALL TIMES, AND CANNOT BE TIED TO A VEHICLE OR LEFT ALONE. **DOGS MUST BE WALKED IN THE PET RUN.** OCCUPANTS WILL BE EVICTED IF THEIR DOGS ENGAGE IN EXCESSIVE BARKING OR DEMONSTRATE AGGRESSIVE BEHAVIOR. **YOU MUST CLEAN UP AFTER YOUR PET.** A \$25.00 PER INCIDENT WILL BE ISSUED
- **RV OCCUPANTS AND THEIR GUESTS MUST OBEY ALL DISTRICT RULES AND REGULATIONS, AS WELL AS ANY DIRECTION OF THE RV MANAGER AND THE DISTRICT SECURITY.** FAILURE TO COMPLY WITH THESE RULES AND REGULATIONS CAN RESULT IN EVICTION OR OTHER ACTION.
- **THERE WILL BE NO REFUNDS FOR OCCUPANTS EVICTED FROM THE FACILITY.**
